

# HICKORY PARK

A SUBDIVISION OF A PART OF THE S.E. 1/4 OF SW 1/4 AND SW 1/4 OF S.E. 1/4, SECTION 5, TWS. 4-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA.

## DESCRIPTION

THE NORTH 940 FEET OF THE S.E. 1/4 OF SW 1/4 AND SW 1/4 OF S.E. 1/4, SECTION 5, TWS. 4-SOUTH, RANGE 17-EAST, COLUMBIA COUNTY, FLORIDA AS LIES BETWEEN THE EAST LINE OF STATE ROAD NO. 25 (U.S. HIGHWAY NO. 41), AS NOW LOCATED, AND THE WEST SHORE LINE OF BIG "ALLIGATOR" LAKE; SAID LANDS BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGIN AT THE SOUTHWEST CORNER OF LAKEWOOD SUBDIVISION, ACCORDING TO PLAT ON FILE AMONG THE PUBLIC RECORDS OF SAID COLUMBIA COUNTY IN PLAT BOOK 2, PAGE 6-C AND RUN THENCE EAST, ALONG THE SOUTH LINE OF SAID LAKEWOOD SUBDIVISION, 978.8 FEET, MORE OR LESS, TO THE SHORE LINE OF SAID BIG "ALLIGATOR" LAKE; THENCE SOUTHERLY, ALONG THE MEANDER OF THE WEST SHORE LINE OF SAID BIG "ALLIGATOR" LAKE, TO A POINT 940 FEET SOUTH, ON A PERPENDICULAR, FROM THE SOUTH LINE OF SAID LAKEWOOD SUBDIVISION; THENCE WEST, PARALLEL TO THE SOUTH LINE OF LAKEWOOD SUBDIVISION, 1350 FEET, MORE OR LESS, TO THE EAST RIGHT OF WAY LINE OF SAID STATE ROAD NO. 25; THENCE N. 7° 05' E., ALONG SAID RIGHT OF WAY LINE, 947.8 FEET TO POINT OF BEGINNING.
