DESCRIPTION:

COMMENCE AT THE N.E. COR. OF THE N.W. 1/4 OF THE N.W. 1/4, SECTION 3, TOWNSHIP 4 SOUTH, RANGE 17 EAST, COLUMBIA COUNTY, FLORIDA, AND RUN S. 0° 31' W. A DISTANCE OF 727.50 FEET FOR A POINT OF BEGINNING; THENCE S. 88° 18' W. 714.87 FEET; THENCE S. 18° 20' E. 305.04 FEET; THENCE N. 88° 18' E. 616.15 FEET; THENCE N. 0° 31' E. 292.50 FEET TO THE POINT OF BEGINNING.

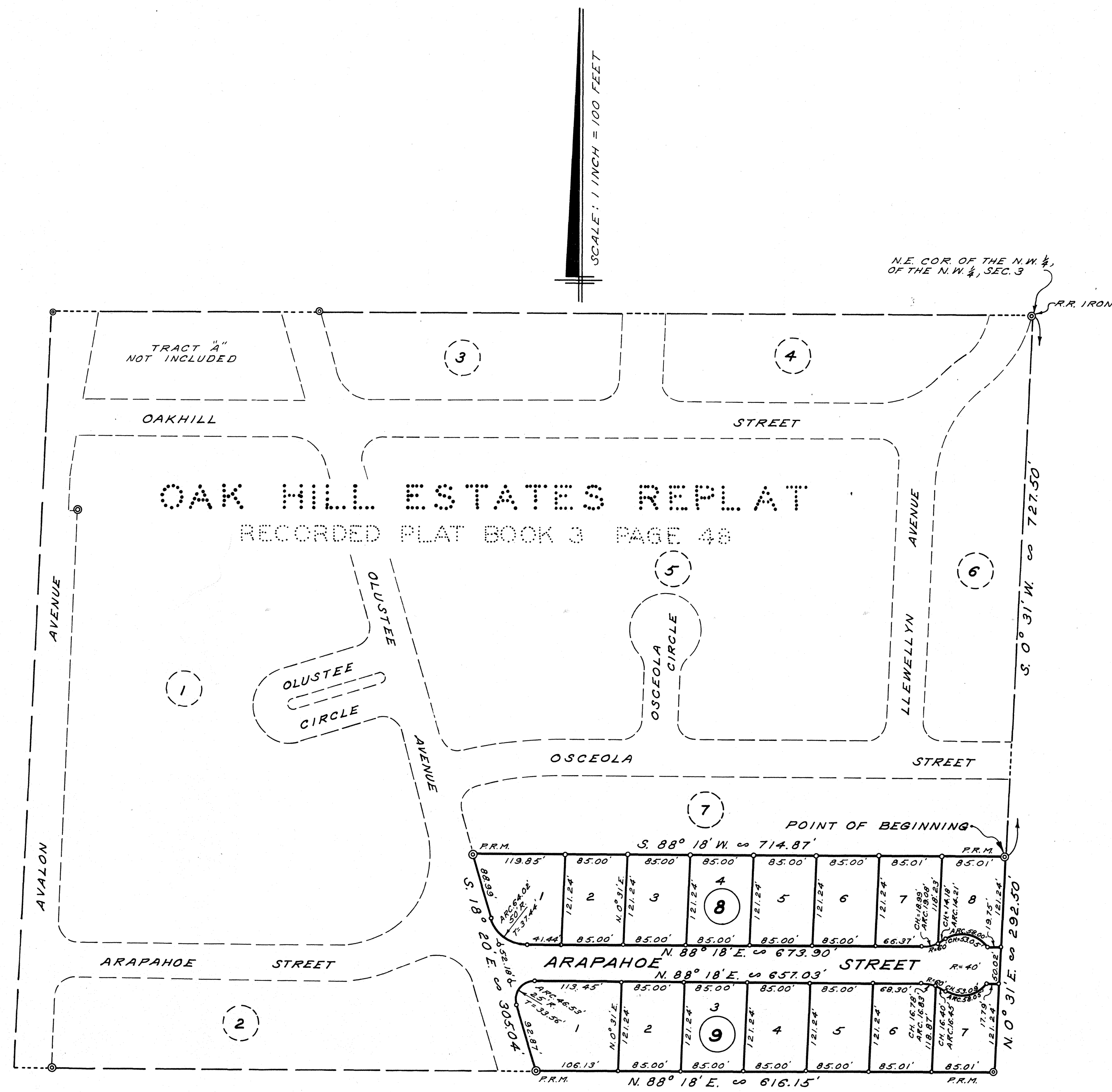
