DESCRIPTION:
 COMMENCE AT THE SOUTHEAST CORNER OF THE SE 1/4 OF SW 1/4, SECTION 20, TOWNSHIP 4 SOUTH, RANGE 17 EAST, AND RUN THENCE N1°06'W ALONG THE EAST LINE OF SAID SE 1/4 OF SW 1/4, 30.0 FEET TO A POINT ON THE NORTH LINE OF STATE ROAD NO. 5-242, THENCE RUN 589°59'W, ALONG SAID NORTH LINE, 135.44 FEET TO A POINT ON THE WEST LINE OF STATE ROAD NO. 5-131; THENCE RUN N1°57'E ALONG SAID WEST LINE 390.0 FEET FOR A POINT OF BEGINNING, THENCE CONTINUE N1°57'E ALONG SAID WEST LINE, 654.13 FEET TO A POINT OF CURVE, THENCE RUN ON A CHORD BEARING OF N1°40'E, THROUGH A CURVE CONCAVE TO THE LEFT, WITH A RADIUS OF 22,918.31 FEET, A CHORD DISTANCE ALONG SAID WEST LINE OF 252.8 FEET, THENCE RUN 389°43'W, 1265.14 FEET, THENCE RUN S1°35'E, 1292.98 FEET TO SAID NORTH LINE OF STATE ROAD NO. 5-242, THENCE RUN N89°50'E, ALONG SAID NORTH LINE 692.61 FEET, THENCE RUN N1°06'W, PARALLEL TO SAID EAST LINE 389.96 FEET, THENCE RUN N89°54'E, 515.51 FEET TO THE POINT OF BEGINNING.
